Bobby Harris Unick, 96, of Pleasanton died at Mother Hull Home on February 13, 2026 in Kearney. Funeral services will be 10:30 a.m. Thursday, February 19, 2026 at Pleasanton United Methodist Church with Rev. Lana Day officiating. Interment will follow at Pleasanton Cemetery.
